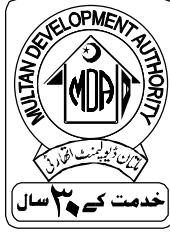

FORM OF SPECIFICATION UNDER REGULATION 3 OF MDA BUILDING REGULATIONS 1986 (TO BE SUBMITTED IN DUPLICATE WITH APPLICATION FORM-A)

1. Materials and methods of construction to be used for external walls, party walls, foundation, roofs, stair cases, bathrooms, fire places, chimneys and damp proof course.	
2. Purpose(s) for which the building is intended to be used.

4. The manner in which drainage of the premises will be disposed off.	
5. Total area of the door-ways and the windows and openings.
